## TERMS AND CONDITIONS FOR THE POST OF MARINE ENGINEER ON CONTRACT BASIS

#### I. QUALIFICATION:

- a) MOT 1st class Motor certificate issued under Merchant Shipping Act 1958.
- b) One year post qualification experience as Chief Engineer/2<sup>nd</sup> Engineer on board a foreign going ship.
- II. Working Timings: The duration of working hours for Marine Engineer on contract basis will be as per office hours with weekly off on Sunday.

#### III. Monthly Remuneration:

- a) The consolidated pay for Marine Engineer on contract basis is ₹94,000/- OR ₹83,000/- when provided with Port quarters.
- b) b) An increment of 5% on consolidated monthly remuneration would be considered for every completed year of service, subject to satisfactory performance.
- IV. Leave entitlement: 20 days Casual Leave per year at the rate of 05 days Casual Leave for every 03 completed months of service. The non availed causal leave can be carried forward to the following year. However, the casual leave cannot be accumulated more than 20 days. If he/she avails himself/herself of leave in excess of his/her casual leave entitlement or absents himself/herself from duty without leave on any day, deduction of a sum proportionate to the period of such absence will be made from the total monthly remuneration payable to him/her by calculating on the basis of the said monthly remuneration divided by 30 for each day of such absence.
- V. Medical facility: Entitled for free In house medical treatment in the NMPA Hospital for self and family to the extent the facilities are available in the Port Hospital
- VI. Tenure of the Engagement: The tenure of the engagement shall be for a period of 3 years from the date of joining the duty/service.
- VII. Security Bond: he/she shall execute a security bond (in the specimen attached herewith) to the effect that he/she will serve in the NMPA as Marine Engineer on contract basis for a period of 3 years from the date of joining the duty/service.



VIII. TA/DA for Tour Travel: As and when required to be deputed on official tour for the purpose of work, he/she will be entitled to draw TA/DA as applicable to the category of the post held by him/her, with prior approval of the Chairperson on each occasion, obtainable through Deputy Conservator, New Mangalore Port Authority. However, whenever he/she is deployed to proceed on voyage by floating crafts to perform temporary duties at places away from this Port's limits, he/she will be entitled to draw Voyage Allowance and Outstation Allowance at the applicable rates, in lieu of TA/DA. He/she will be entitled to draw the Voyage Allowances and Outstation Allowances with the prior approval of the Chairperson on each occasion, obtainable through the Deputy Conservator, New Mangalore Port Authority. No TA/DA will be paid for joining for duty in response to this offer.

**IX.** Accommodation: He/she will be permitted to occupy the Port Quarters if he/she opts for the same. The class of accommodation that would be allotted to him/her shall commensurate with the post held by him/her subject to availability of vacant quarters. However, proportionate deductions will be made from the monthly consolidated salary payable to him/her as mentioned herein before. In addition, allied charges such as the license fee, water charges and electricity charges will have to be borne by the occupant.

**X. Other Service Benefits**: For the purpose of attributability for the injuries sustained by him/her during his course of duty, Marine Engineer on contract basis will be treated as an employee of the New Mangalore Port Authority only during his/her duty hours.

XI. Termination of Contract: His/her engagement as Marine Engineer on contract basis can be terminated by either side by giving one month's notice during the currency of the contract.

**XII.** Claim for permanent absorption: The contract engagement shall not confer on him/her any right to lay claim to permanent absorption in the port service against any post whatsoever.

**XIII.** Settlement of Disputes: In the event of any dispute arising out of this contract, the interpretation and decision of the Chairperson, New Mangalore Port Authority will be final and binding.



If the candidate is amenable to the terms and conditions set out above, he/she will be required to execute a security bond in the format given herewith for the period of engagement as a Marine Engineer on Contract basis and join for duty on the stipulated date. On the other hand, if he/she is not in a position to join for duty by the said date, he/she must send necessary communications duly intimating the date by which he/she will be able to join for duty as a Marine Engineer on contract basis at this port. If he/she fails to comply with both the options, this offer will stand cancelled.

In addition to the above, the contract Marine Engineer must take note of the fact that his/her engagement to the post of Marine Engineer on contract basis shall be subject to his/her being medically fit for the duties to be performed in the said post. Therefore, the candidate selected for engagement as a Marine Engineer on contract basis will, at the first instance, have to report to the Chief Medical Officer of the Port Authority Hospital of this Port to undergo necessary medical examinations prior to joining for duty as Marine Engineer on contract basis at this Port.
