2. The fault to be located as and when required / on receipt of intimation from NMPA within 3 days.
3. Please note that no advance payment will be made, but payment will be made within 15 days after satisfactory completion of each fault location work to the entire satisfaction of the Engineer-in-Charge against invoice/bill along with report.
4. Income Tax at the applicable rates will be recovered from the gross amount of the firm's bill as per the relevant provisions of the Acts.
5. The Rates quoted should be valid for **90 days**.
6. Contractor shall be responsible for making good of all the damages done during the work and has to employ skilled & competent workers for carrying out the work.
7. No Men, Materials, Testing Equipments, Food & Accommodation, Transport etc. required for the work will be supplied departmentally and Contractor have to make their own arrangement.
8. Port entry passes to the Contractor and his workmen and vehicle during the period of work will be issued to carry out the work as per rules on chargeable basis.
9. The Tenderer shall be responsible for taking precautionary measures for the safety of the workmen working under him and the responsibility arising due to any mishap during the execution of work, payment of any compensation etc., lies entirely on the part of the Contractor. Safety Items required while working are to be provided by the Contractor.
