Some of the Container Vessel Operators have requested for allotment of Fixed Window Slot/Change of Schedule of their allotted Window. Also Port has commenced simultaneous handling of two Container Vessels at Berth No.14 within permissible LOA limit for addressing bunching of vessel due to Red Sea-induced congestion at Trans-shipment Ports.

In order to accommodate above charges in Fixed Berthing Window Schedule a meeting was held on 30.08.2024 with Container Vessel Operators and Container Terminal Operator wherein it was agreed to revise the Fixed Window Schedule under provision of Clause No.8 of subject policy circulated vide Trade Notice dtd. 20<sup>th</sup> September 2022. These updates, made in consultation with the Container Vessel Operators and Terminal Operator, ensure seamless berth planning in the interest of both the trade and the port.

The revisions are as follows keeping policy's other terms and conditions unaltered:
