- 1. NEW MANGALORE PORT AUTHORITY** the Seller, will be hereinafter referred to as NMPA and MSTC Ltd., the Selling Agent of NMPA will be hereinafter referred to as MSTC. Wherever the word Buyer, Purchaser, Successful Bidder is indicated, it will be referred to as Successful Bidder.
- 2. VALIDITY OF BIDS:** All bids will be valid for acceptance by MSTC for a period of 60 (SIXTY) days from the date of closing of e-Auction (excluding the date of closing of e-Auctions). In case the 60th day falls on a holiday or remains closed for MSTC, such bids will be deemed to be automatically extended to be valid up to the next working day of MSTC.
- 3. INSPECTION:** Opening and closing dates of inspection is given in auction details. - 4.** The description/quality indicated are approximate and furnished to enable bidders to quote their rates. Bidders are advised to quote their rates only after inspection of items at site. The sale could be neither invalidated nor the bidder can make any claim/compensation whatsoever on account of any defect in description, deficiency in the quantity and quality. Notwithstanding anything contained in the e-Auction sale notice or advertisement issued as to description and particulars of material put up for sale, the sale is on AS IS WHERE IS basis only. NMPA/MSTC, do not give any assurance or guarantee that the materials to be delivered will adhere to notice or advertisement or list. No plea or misunderstanding or ignorance or conditions put forth subsequent to any confirmation of sale shall be accepted. The principle of CAVEAT EMPTOR (let the buyer be aware) will apply.
- 5.** Conditional offers will not be accepted /entertained.
- 6.** Goods/Equipment/Items will be sold on AS IS WHERE IS condition and the whole items shall be taken delivery from the site by the successful bidders with its faults, errors in description if any. In mixed lot, picking items at random is not allowed and Loading should be done as a whole without choosing and picking.

The quantities mentioned either by weight or measurement as mentioned in the e-auction sale catalogue are approximate and weighment of the lot will be done at the time of delivery. The payment must be made as per actual counter weight and bidder is bound to lift entire quantity of the lot. In case actual weighment exceeds the indicated approximate quantity, then payment for the extra quantity has to be made at the same rate, before taking delivery of material. For LOTs which mentioned in auction as on one (01) LOT shall be delivered without weighment after payment and bidder is bound to lift entire quantity of the lot.

- 7.** The items shall remain in every aspect at the risk of the buyer from the time of acceptance of his offer. NMPA/MSTC will not undertake any liability whatsoever for the safe custody, protection or preservation after the sale has been confirmed. Delivery of the lot as put up for sale, subject to change by nature's wear and tear, will be affected by the buyer. No complaint

regarding quality or mis-description for the materials sold will be entertained once the bid has been accepted.

- 8. GST:** GST as per the prevailing tariff wherever applicable at the time of delivery on the sale of materials covered under this e-Auction shall be payable by the successful bidders directly to NMPA at the time of taking delivery of materials. The present rate of GST applicable is indicated in the 'Auction Details'.

GST rates as indicated in this e-auction catalogue are only indicative. Actual GST rates as applicable on the date of lifting shall be applicable. Bidders are required to satisfy themselves about GST rate through their own sources/means before bidding in this e-auction and any discrepancy should be intimated to MSTC/Seller at least one working day prior to the e-auction. No complaint from any bidder thereafter, regarding any variation will be entertained after the e-auction goes on live floor. Non-payment of sale proceeds on the ground of any discrepancy of GST rate will be treated as default and action as deemed fit including but not limited to forfeiture of EMD/SD will be taken against the bidder.

- 9. INCOME TAX:** INCOME TAX APPLICABLE @ 1.0% ON THE TOTAL SALE VALUE OF SCRAP (TOTAL SALE VALUE=MATERIAL VALUE+ GST + ANY OTHER LEVY, IF ANY) UNDER SECTION 206C OF INCOME TAX ACT 1961 will be levied. ANY CHANGES IN THE SAID TAX WILL HAVE TO BE BORNE BY THE BUYER.

10. SECURITY DEPOSIT (EMD):

- i) It is the responsibility of the Bidders to check the status of their bids after the closing of the e-auction and pay the SD amount within 10(Ten) calendar days from the date of closing of e-auction (excluding the date of closing of e-Auction) for Sold/Accepted Lot. For STA lot, SD has to be paid within 10 (Ten) calendar days from the date of confirmation/approval of bid (sale intimation).

The bidder has to deposit SD equivalent to 25% of Material value within 10 (Ten) days by e-payment to the NMPA, **failing which the Login of the buyer will be deactivated in addition to other actions as deemed fit.** In case of STA lot, 25% of the material value to be paid within 10 (Ten) days after confirmation of the STA lot. Balance payment to be made within 10 days from the date of Sale Order/Acceptance Letter issued by the MSTC,(Ref. Clause No.11 and 12)

- ii) If bidder does not make SD payment within 10days, total payment (100%, including GST, TCS etc.) has to be made within 20 days. In such case login ID of the buyer will be activated after receipt of total 100% payment (Including GST, TCS, ITTDS, etc.). If the buyer fails to make 100% payment within this period the **Pre-Bid EMD / & SD(EMD) will stand forfeited without any notice** and the firm will be debarred/deactivated in addition to other actions as deemed fit.

11. ISSUANCE OF ACCEPTANCE LETTER/SALE ORDER: On receipt of EMD, an Acceptance Letter/Sale Order will be issued by MSTC for sold lot.

12. PAYMENT: i) On receipt of Acceptance Letter/Sale Order, balance payment has to be made within 10 (ten) calendar days from the date of issue of Acceptance Letter/Sale Order (Excluding the date of issue).

ii) The balance amount (after deducting the EMD) plus applicable GST /TCS/duties, INCOME TAX and other charges if any must be paid in favour of The New Mangalore Port Authority. ITTDS payment to be made in favour of MSTC, Bangalore.

iii) If the bidder does not make balance payment within 10 days as stated in 12(i), then late payment charges @ 1% per week **or** part thereof up to a maximum of 02 weeks will be levied on total material value. If the bidder fails to make payment within this period then EMD/SD will be forfeited without notice and the firm will be debarred/deactivated in addition to other actions as deemed fit..

iv) In case, the last day of payment happens to be Closed Holiday for MSTC or Banking Institutions, the next working day will be taken as the day of payment without late payment charges. The decision of MSTC/NMPA with regards to acceptance/rejection of Bank holiday claim of Bidder shall be final and binding.

v) In addition to the above, any delay in payment of balance amount beyond the stipulated time in the e-auction catalogue the rejection/acceptance of payment/forfeiture of full amount already made will be at the discretion of the NMPA and the decision is final. **Any statutory variations of rate of Taxes/Duties are to be borne by the purchaser.**

13. DELIVERY TERMS:

A) The Delivery order will be issued after receipt of the above mentioned payments. Delivery has to be taken within **25 (Twenty five) calendar days from the date of Sale Order/Acceptance Letter** issued against the confirmed lot (excluding the date of issue). The delivery of material will be given after realization of the DD/PO/BCs. Further, Delivery of hazardous wastes of **Released/Used oil, Batteries and e-wastes** has to be taken by the successful buyer is within 21 (twenty one) calendar days from the date of issue of Delivery Order from MSTC (excluding the date of issue of Delivery Order). In case of delay in taking delivery penalty will be levied @ **1% on material value** per week or part thereof will be charged up to 2 (Two) weeks only and thereafter **relevant payments paid by the buyer will stand forfeited without any notice.**

However further extension of the delivery period may be given as a special case at the discretion of the Competent Authority NMPA, with **or** without additional ground rent. If the last date of delivery falls on a closed holiday of NMPA, immediate next working day of NMPA shall be taken as last date of delivery. Materials sold but not removed within the specified date, will

become the property of NMPA and it will have the right to dispose of such goods in any manner as they deem fit without any notice.

B) The lot description for the corresponding materials specified Lot which is mentioned **UOM is on weight/measurement basis (Kg/Ton/Litre/KL)** is delivered “as is where is condition” **on weight/measurement basis only**. The Materials which are **SOLD ON LOT BASIS** will be delivered “as is where is condition” **without weighment/measurement**, further details of approximate quantity mentioned in lot description is for the bidders reference purpose to know the approximate quantity of that lot for before participating the auction. The Used/Waste Oil and Batteries shall be taken delivery in as is where condition basis and strictly separation of Oil & Water **OR** Removing water etc. **shall not be allowed at site**.

C) SALE OF ITEM/LOT COMPRISING VEHICLE:

- i)** In case of sale involving inter-State movement of vehicle, the Buyer shall also submit a No objection Certificate (NOC) from the concerned State with whom the Buyer is registered and also from RTO to the NMPA before taking delivery, failing which the Buyer will be responsible for all the consequences and the NMPA shall take further decision as may be deemed fit by them.
- ii)** NMPA reserves its right to demand copy of any other document/License/ Certificate issued by any RTO/Govt. Authority in favour of the Bidder, if required under any Statutory or State/Central Government Act/Law/Order/Rules, etc.

14. No delivery of material will be given on Saturdays, Sundays and closed holidays observed by NMPA. Materials will be delivered between 10.00 hrs and 16.00 hrs on any working day. The **purchaser should intimate in writing two days in advance** as to when vehicle will come for taking out the materials. The material will be delivered only to the successful bidder **or** their authorized representatives against presentation of Buyer Identity Card issued by MSTC. If the successful bidder desires to authorize a representative **or** an agent for delivery, in such case the successful bidder **or** his authorized representative shall produce suitable Power of Attorney **or** authorization letter separately duly attested by a Notary.

15. Any welding/cutting work within the Port premises during dismantling work shall be arranged only with the prior permission from Fire & Assistant Safety Officer / NEW MANGALORE PORT AUTHORITY.

16. NMPA/MSTC reserves its right to demand copy of any other document/Licence/ Certificate issued by any Statutory/Govt. Authority in favour of the Bidder, if required, under any Statutory or State/Central Government Act/Law/Order/Rules, etc.

17. NMPA/MSTC reserves the right to accept / reject and cancel any bid at any stage under this e-Auction sale after acceptance of bid / issue of sale order / deposit of full sale value by the bidder, without assigning any reason thereof and the value of such material if paid for shall be

refundable. NMPA / MSTC shall not be responsible for any damages / loss whatsoever to bidders on account of such withdrawal, at any stage from the e-Auction sale.

- 18.** NMPA/MSTC will not be in any way responsible for failure to deliver the materials due to cause beyond their control such as strike, lockout, cessation of work by labourers, shortened hours, act of GOD or other causes or other contingencies whatsoever. The buyer shall not be entitled to cancel the contract and the period of delivery shall automatically get extended proportionately.
- 19. CONDUCT DURING DELIVERY:** Buyers shall solely be responsible for movement and proper behavior of their deputies, agents, and labourers within NMPA premises. If any damage is caused to the NMPA property, the buyer is responsible to make good such damage to the satisfaction of NMPA and the decision of NMPA in this regard shall be final and binding.
- 20. ACCIDENTS ETC. TO BUYERS LABOURER:** NMPA/MSTC will not at any point of time be responsible for any injuries caused due to accident within the NMPA premises **or** at the place of work/salvage yard. The buyer should make proper arrangement for medical attention and treatment to his labours. The buyer will be solely responsible for any claim arising out of the employment, injuries to labourers in the course of employment under any statute. It is the responsibility of the buyer to provide necessary safety appliances (like hand gloves, ammunition, boots, helmets, nose masks etc.) to the labourers who are engaged for handling of the goods.
- 21. BLACKLISTING:** If it is found that the bidder is not following the terms and conditions of payment /delivery **or** other conditions of the e-auction and also indulging in any malpractices either himself or by his agents, deputies or observer, such bidder are liable to be blacklisted & appropriate action will be taken as deem fit by NMPA/MSTC. If bid is accepted, but bidder / firm / buyer fails to make all the payments within stipulated period, in such cases the bidder/firm/buyer are liable to be blacklisted from further NMPA auctions for a period of 02 years from the date of e-auction.
- 22.** In the event of any dispute in connection with this sale, the decision of NMPA / MSTC shall be final and binding on the parties to the e-Auction sale. Further any such dispute, doubts or differences of opinion arising at the time of Payment or Delivery, bidder shall agree and abide by the decision of NMPA/MSTC.
- 23.** No interest will be paid to the purchaser on the amount paid **or** deposited by him and on the amount refundable to him, if any.
- 24.** In the event of any disputes or differences in connection with the contract, the decision of the Chief Mechanical Engg., NMPA shall be final and binding on all parties. All disputes arising

out of this e-auction will be settled as per the Indian Law in the Court Jurisdiction of MANGALORE only.

25. The terms and conditions are supplementary to the remedy available under the law.
26. Any auctioned materials shall not be sold or parted with to any of the employees of NMPA/MSTC
27. The buyer should ensure that Sales/Customs/RTO and all other statutory formalities as required are complied with where ever necessary and expenses including tax/insurance charges etc. should be borne by buyer.
28. **FAILURE TO TAKE DELIVERY AFTER PAYMENT:** In the event of non-removal of sold material after expiry of time allowed in the relevant order and subsequent extension(s) thereof, if any, the principal/owner of the material shall have the right to order re-sale of the said material as also to forfeit relevant payments paid by the defaulting buyer in respect thereof.
29. No packing, sorting, cutting or breaking of goods **or** materials sold will be permitted unless otherwise it is specified. Further if it is difficult to load and barrier to transport the materials, **in such cases it may be provided** for convenient to transporting and loading the materials.
30. The purchaser shall bring their own bags and boxes, cases or their receptacles for the removal of the auctioned items and shall be responsible for loading, weighment/ measurement of materials under supervision of authorized official of the NMPA.
31. All quantities either by weight **or** measurement as mentioned in the e-Auction sale catalogue are approximate. If exceeds the mentioned weight **or** measurement, the payment must be made as per actual counter weight. Also, if the delivery of actual quantity in any lot exceeds the quantity indicated in the e-Auction sale catalogue, the actual delivery quantity shall be restricted to the declared quantity in the catalogue including the tolerance limits as specified above. NMPA reserves the right to retain the excess quantity material in the lot at its discretion.
32. If the quantity in a lot on actual weighment/measurement **or** count is less than the announced quantity as indicated in the e-Auction material list, NMPA will not make good the deficiency under any circumstances. The purchaser thereof will be entitled to obtain a **refund for the undelivered quantity at accepted rates**. No interest will be paid on the amount of short delivered quantity.
33. If any foreign materials are found to be mixed in the lot, other than the items included in the e-Auction catalogue, Acceptance Letter/Sale Order, Delivery Order the NMPA reserves the right to remove the same at the time of delivery.
34. **Additional conditions:**
 - i) Buyer should ensure that all precautions have been taken to prevent damage to coastal areas and marine life.

- ii)** It is the responsibility of the Buyer to provide necessary personal insurance to his staff or labourers.
- iii)** On handing over of lot to the buyer, all types of commercial/financial/statutory/legal issues directly **or** indirectly related to the lot shall be the responsibility of the Buyer.
