- **2.** The bidder shall submit GST Registration certificate along with the quotation.
- **3.** The quotation shall be valid for a period of 9 months

- **5.** No advance payment will be made. 100% Payment shall be made within 15 days from the date of receipt of Invoice along with calibration certificate.
- **6.** Applicable statutory taxes if any will be deducted at source while making the payment.
- **7.** The calibration shall be conducted at your facility. The meters will be shipped to your facility duly packed as per postal standards and shipped via India post parcel service for which complete postal address of your facility shall be provided. The cost of packing and onward courier will be in our scope.
- **8.** The bidder shall confirm the receipt of the meters at your facility upon arrival of the same.
- **9.** After completion of calibration service, the equipments shall be returned to our facility **in good working condition** neatly packed with care as per standards with **transit insurance**. The cost of packing, return courier charges and transit insurance shall be included in the rates quoted above.
- **10.** The calibration results shall be traceable to national standards, Radiation Standard Section (RSSD)-BARC
- **11.** Laboratory shall not use external service provider either part or full for laboratory activities
- **12.** Statement of conformity for calibration result based on the tolerance limit (Specified by AERB).
- **13.** Any deviation from the service request, shall be discussed & resolved before commencement of the calibration activities.
- **14.** The acceptance of the tender will rest with Competent Authority of NMPA who does not bind himself to accept the lowest tender and reserves to himself

the authority to reject any or all of the tenders received without assigning any reason.
