

Balance 10% payment will be withheld till the completion of Guarantee period of 06 months and the same shall be released without interest after completion of Guarantee period.
5. The work shall be completed within 10 days from the date of issue of Work order.
6. The work will be carried out to the entire satisfaction of Engineer In Charge, OTM Sub Division, NMPA.
7. Statutory taxes as applicable will be deducted while releasing payment.

The Tenderers may visit the work site (Oil Jetty Area), NMPA and asses the details of work to be carried out and get acquainted with the work involved before submitting the quotations by conducting the AEE(M), OTM Sub Division or the undersigned. Any assistance in this regard will be provided by the Department.
