TERMS & CONDITIONS:

- 1. The rate quoted for the items shall be firm and F.O.R destination basis. Please note that NMPA is not issuing any concessional C or D forms.
- 2. The Tenderer shall submit GST Registration Certificate along with their offer, without which the offer is liable for rejection.
- 3. Applicable GST will be paid as extra as per actual.
- 4. The time allowed for completion of work is **15 days** from the date of issue of work order.
- 5. The carried out work shall have one year Guarantee from the date of handing over after satisfactory completion of work.
- 6. Please note that no advance payment will be made. But payment will be made within 15 days after satisfactory completion of Work.
- 7. Offer shall be submitted in NMPA format only along with Terms & Conditions of Enquiry. Offer submitted in other format will not be considered for evaluation and liable for rejection.
- 8. The Tenderers should quote their rates in figures as well as in words the amount tendered by them. The amount per each item should be worked out and requisite total should be given. All rates shall be quoted in proper form in the tender schedule enclosed. The rates quoted should be valid for **90 days**.
- 9. The Tenderer shall be responsible for making good of all the damages done during the work and has to employ skilled & competent workers for carrying out the work.
- 10. The Tenderer shall be responsible for taking precautionary measures for the safety of the workman working under them and the responsibility arising due to any mishap during the execution of work, the payment of any compensation etc., lies entirely on the part of the Contractor.
- 11. No tools, plant, Labour, equipment, transport, etc., required for the work will be supplied departmentally and contractor has to make his own arrangements.
- 12. The evaluation shall be done on the basis of total lowest value (L1) quoted. The GST element if any will not be considered for evaluation.

13. The acceptance of the tender will rest with competent authority of NMPA who does not bind himself to accept the lowest tender and reserves to himself the authority to reject any or all of the tenders received without assigning any reason.

14. LIQUIDATED DAMAGES:

- i. In case of delay in completion of the contract, liquidated damages (L.D) may be levied at the rate of 0.5% of the contract price plus applicable GST per week of delay, or part thereof subject to a maximum of 10 per cent of the contract price.
- 15. If the Tenderer after award of work/contract fail to execute the work in the specified allotted period, then the Tenderer shall be debarred for a period of two (2) years from participating for tenders at New Mangalore Port Authority.
 - 16. The specification of the UTP cable is enclosed in Annexure -I, Boucher of UTP cable is to be enclosed alongwith the bid.
 - 17. Bidder should visit the site before quoting.
