Sub: Prohibition of Two-Wheeled Vehicle Entry Within Port

It is to inform that in the wake of frequent accidents occurring within the dock area of the Port, a comprehensive review was made. To ensure the highest safety standards and to prevent any future recurrence of such incidents, it has been decided that effective June 15, 2025, the entry and operation of all two-wheeler vehicles are strictly prohibited within the dock area of the Port. This will be enforced at all three notified Port entry gates.

Arrangements are duly made for parking space for port employees at the Traffic Building where they have to park their vehicles, handover the keys to the Security Guard.

For movement in dock area separate arrangement for vehicle will be done shortly.
